APPROVAL OF PAYMENT REQUEST NO. 6 – BWC EXCAVATING IN THE AMOUNT OF \$42,045.41: Marc Ruden informed council that this is not Final payment request. Origin did a walkthrough of the subdivision today to determine a punch list of items that need to be finished up, but over-all it looks good. There will be a retainage held, plus double the cost of the value of punch list items for 30 days before final payment will be released. Discussion was held regarding the elevation levels. Council asked if they were done according to blue prints because of the slope on the south side. Ruden reported that it was graded according to specs and it followed the standard of care. Council wants to be sure it is included in the covenant that fill dirt must stay in the sub division and the City designates where the dirt is placed. A motion was made to approve Payment request to BWC in the amount of \$42,045.41 by M. Petersen. Seconded by JT Thomson. Motion carried unanimously.

SPONSORED PROJECT UPDATE: Marc Ruden reported that the project was still at the 60% - Review State Level. There are many items included in this level and he is working with them to determine what's a must and what's a suggestion to continue moving this forward. There are critical dates that need to be met. The project needs to go out for bid and the loan amendment approved before the 1st loan payment is made on June 1 2022 on the WWTP loan. Once a principal payment is made, 10% of that goes towards the Sponsored project. Ruden is pushing for a meeting to ensure deadlines are met so we don't loose grant dollars. Bids are needed by March 2022. Once that meeting takes place, he will report back to council.

APPOINTING TERESA WEINSCHENK TO JCEA BOARD for 2022: Teresa has served on the JCEA board for the past year and her position is up for renewal as she had filled the vacant spot for Patti Hoffman. M. Petersen felt that council should continue supporting Teresa's position on the board representing Preston. A motion to approved appointing Teresa to JCEA board was made by A. Reuter, seconded by M. Gerardy. Motion carried unanimously.

IISC PROJECTS: Through the lowa Initiative for Sustainable Communities Program, Univ of IA students are currently partnering with Preston. Up for Spring semester are Pedestrian/Trails Connectivity and Copper Creek Campground projects. Consensus of Council is that this is a good relationship and to continue working forward on the currently scheduled projects and include Branding as they students have already assisted in the Marketing of Harvest Heights.

IOWA DOT APPLICATION FOR PEDESTRIAN CROSSINGS: Due to the current sidewalks not being ADA compliant, the Iowa DOT is rejecting the application at this time until the sidewalks can be installed according to the Iowa DOT guidelines in the spring then application can re-submitted for installing the pedestrian crossing signs.

TREE BOARD AND ORDINANCE UPDATE: A sample Tree Ordinance was reviewed by council. The sample ordinance included having a named "City Forester". Council would like to eliminate Forester and word it so that decisions are made by the "Consensus of the Tree Board". The Sample also limited board members to residents, council would like to change the word "residents" and open it up to surrounding "community members". Revisions are to be made and presented again at the next meeting.

WPPI METERING PROGRAM UPDATE: As part of the services WPPI provides is testing of Electric Meters. During resent testing it was discovered that there were some 3 phase commercial meters not correctly reading on all phases, creating a loss in revenue. Council would like to see Ray implement and report back on how he can track line loss and see what is the standard of percentage of acceptability is. Council would like to see all Utility Heads take turns attending 1 meeting per month and report back to council to discuss updates, needs and answer questions.

OATH OF OFFICE: Mayor Sieverding conducted the Oath of Office for elected council members: Matt Petersen, Matt Gerardy, Adam Reuter and JT Thomson. The Police Chief was called away on a call.

UPDATE ON U.S. CENSUS NUMBERS: A mailing has been sent to all residents of Preston in attempt to challenge the number of the 2020 Census. Preston's numbers are down from 1012 to 949. This decrease plays a huge deal in funding for Preston and Mayor Sieverding wants to encourage people to please respond and get the word out.

OTHER BUSINESS: A reminder that there is a Preston Growth & Development meeting this Thursday, Dec 16th at 6:00pm. Invites were mailed, notice was on Facebook and City website.

MOTION TO ADJOURN: With no further business to be presented to council, Mayor Sieverding asked for motion to adjourn. Motion to adjourn was made by M. Gerardy and seconded by JT Thomson. Motion carried unanimously. Meeting adjourned at 6:57 pm.
