ORDINANCE 11: An Ordinance amending and repealing the code of Ordinances of the City of Preston, by amending and repealing a portion of Title II, Policy and Administration, Chapter 5, Salaries of Municipal Officers s, 2-5-1 Council Members & 2-5-2 Mayor:

The 1st reading or Ordinance 11 – for setting salaries for Council members to 1500/year to be paid out bi-annually and Mayor to \$3000/year to be paid out bi-annually was held. Gerardy. Motion carried.

RESOLUTION 2023-10: Employing and Setting Salary for the Police Chief: City Personnel Committee has made recommendation to Council to hire Chad Gruver as Preston Police Chief. A resolution approving the appointment and setting the salary of the position at \$39.00 per hour effective Sept. 11, 2023, was presented. A motion to approve hiring Chad Gruver and setting salary at \$39/hr. was made by M. Petersen, Seconded by JT Thomson. Motion carried.

OTHER BUSINESS:

- Preston Downtown Walk Around Report: The summary report from Iowa Economic Development was received and discussed. The Team supplied recommendations to assist Preston in addressing challenges downtown includes Marketing: Promote positive things happening to encourage potential visitors to our area through social media. Signage: Wayfinding signage along Hwy 64 to clearly communicate where the business district is and establish branding. Streetscape: Pay attention to little details in making visits to Downtown Preston memorable. Other contact information and funding resources were also provided.
- Squad Car: Ganzer updated that the repairs needed for the Charger will be turned in as an accident claim to the insurance do to the damage being more extensive than originally thought.
- Ellis Development Update: The contractor has requested zoning of property and a potential development agreement which is being looked into.

ADJOURNMENT: With no other business, Mayor Sieverding asked for a motion to adjourn. Motion to adjourn was made by A. Reuter, seconded by JT Thomson. Motion carried. Meeting adjourned at 6:20 p.m.
